Implementation of Smart ID Attendance Registration and Amendments to the Terms & Condition of the Haemodialysis Public-Private Partnership (HD PPP) Programme (the Programme)

Thank you for your participation and support to the Programme. We would like to inform you for the following updates under HD PPP which will be effective from 1 March 2021 (Monday).

A. Implementation of Smart ID Attendance Registration

To enhance the accuracy of record on service delivery, Smart ID attendance registration will be implemented on 1 March 2021. You will be no longer required to sign on the HD Treatment Summary after HD treatment at the Community HD Centre. Alternatively, you will be asked to register your attendance when you are present at the Community HD Centre by:

1. inserting your Hong Kong smart identity card into a government-approved card reader at the Community HD centre ; or
2. providing the one-time password (OTP) generated by the Electronic Health Record Sharing System (eHRSS) which is sent to your registered mobile number or email address.

You are strongly encouraged to bring along your Hong Kong smart identity card for HD treatment at Community HD Centre, and to update your communication means on eHRSS such that you can receive the OTP for the purpose of attendance registration. Please refer to the Attachment 1 for the ways of updating your communication means on eHRSS for your action.

B. Amendments to the Patient Consent and Terms and Conditions

Please noted that the paragraphs under Patient Consent and Terms and Conditions (T&Cs) of the HD PPP have been re-organized. Some of the paragraphs are amended and newly added under T&Cs with effect from 1 March 2021. Relevant paragraphs are summarized in the below table for your easy reference:
