New Co-payment Arrangements for Haemodialysis Public-Private Partnership Programme

Thank you for your continued support to the Haemodialysis Public-Private Partnership Programme (HDPPP).

As announced earlier on 25 March 2025, the Hospital Authority (HA) will implement the Public Healthcare Fees and Charges Reform starting 1 January 2026.

Under the Terms and Conditions of the HDPPP, all existing patients, together with newly participating patients, are required to pay co-payment amounts equivalent to the HA fees & charges as set out in the Gazette to receive services.

The HA will support private service providers in adopting the new payment arrangement. The relevant IT system will be enhanced to automatically calculate and display the new Gazette fees and the appropriate co-payment amounts that patients need to pay starting from 1 January 2026.

The following co-payment will take effect from 1 January 2026:

Service	Fees effective from 1 January 2026
Day Procedure (Renal Clinic)	\$250 per attendance

Categories	Treatment Fee per Attendance
Public Charges	\$250
25% waiver	\$188
50% waiver	\$125
75% waiver	\$63
Full waiver*	\$0
Civil Service Eligible Person	\$0
HA Staff & Dependent	\$0

* Full waiver refers to 1) Recipient of Comprehensive Social Security Assistance (CSSA); 2) A holder of valid full medical fee waiver certificates issued by authorized Hong Kong Government or Hospital Authority social workers; 3) Old Age Living Allowance Recipients aged 75 or above; 4) Level 0 Voucher Holder of Residential Care Service Voucher (RCSV) for the Elderly

In addition to the existing medical fee waiving mechanism, the HA establishes a second safety net by introducing a HK\$10,000 cap on an eligible patient's annual spending for specified public medical fees and charges without requiring financial assessment with effect from 1 January 2026. The fees and charges payable by the patient being an Eligible Person to private practitioners under this programme will be counted towards the eligible medical fees and charges of the Annual Spending Cap. amount can be checked via HA Go, One-Stop Electronic Kiosk and any hospital's Shroff office. Patients should refer to the Guide on Annual Spending Cap for details.

Meanwhile, our Programme Office will also send letters to all programme patients to inform them the new fees and charges structure and provide channels for enquiries.
